Director of Nursing: Kelli Kidd

Bethesda is excited to introduce Kelli Kidd as our new Director of Nursing. Kelli has her RN degree from Hutchinson Community College. The Director of Nursing (DON) oversees the nursing department and as a result has the responsibility of maintaining Bethesda's compliance to the many state and federal nursing regulations. Other responsibilities include monitoring that all resident needs are met, implementing person centered care approaches, supervising approximately 45 staff members, and developing, updating and maintaining policies and procedures that govern the day-to-day functions of the nursing department.

Kelli has been in nursing for over 20 years; most of her career has been spent in the long term care setting. She was a C.N.A. for 5 years, was a Home Health Aide, a CMA for 5 years. Kelli went to school to get her Licensed Practical Nurse license, and then a few years later went on to get her Registered Nurse degree. The 6 years prior to working at Bethesda Kelli was in the role of Director of Nursing. Kelli

brings to Bethesda a sense of compassion and calmness. Working her way from C.N.A to Registered Nurse, along with working alongside many great colleagues over the years, has given Kelli many tools to be successful in her role as DON.

The sense of belonging and the family atmosphere at Bethesda have been a great joy for Kelli already. "When you walk in the door, you are greeted by warm, loving staff and residents. I chose to work at Bethesda because I want to be part of a Christian non-profit community and ministry." Before coming to Bethesda Kelli was working for a for-profit long term care corporation. After being there for a short time she knew that it was not the environment or change she was after. "When I got a call from Eric asking if I would be interested in meeting to talk about the Director of Nursing position at Bethesda, it was confirmation that I was not in the right place." MUSIC & MEMORY

MUSIC & MEMORY is a non-profit organization that brings personalized music into the lives of the elderly through digital music technology, vastly improving quality of life. The Music and Memory Program creates and provides personalized playlists using iPods and related digital audio systems that enable those struggling with Alzheimer’s, dementia, behaviors and other cognitive and physical challenges to reconnect with the world through music-triggered memories. Music is in the long-term memory and is very active in the brains of those with dementia and cognitive challenges.

In March of 2016 Bethesda Home applied for, and received a grant from the State of Kansas Ombudsman office to participate in the Music and Memory Program. Through the grant, Bethesda received seven iPod Shuffle music players, headphones and iTunes gift cards to purchase music for residents. The Kansas State Ombudsman office, along with the Music and Memory program aim to decrease the behaviors of residents who have a diagnosis of dementia, decrease the amount and severity of chronic pain that resident’s experience and lower and treat symptoms of depression.

The long term goal is that Bethesda will have individual iPod Shuffle players for all residents. Each player will

have music specific to the resident and their interests. Music preference is gathered from residents when possible, family members, or resident music collections. Currently we have types of music for our residents on the program that range from Heavy Metal to Classical as each person has unique musical tastes.

As supporters of Bethesda Home you can help make this goal a reality. Currently we have 17 residents who have iPod Shuffles loaded with the music that fits their personality and preferences. The hope is to obtain funding to purchase iPod music players for all of our residents. Gifts for this project can include financial donations for equipment purchase, or CD’s for Bethesda to have (we have to have possession of the music we use so we cannot copy CD’s and give them back – we have to own the CD).

Tax-Free Gift Option for Those 70^{1/2} and Older

Remember – December 2015 the IRA charitable gift option was made permanent. Persons 70^{1/2} or older can make a donation of up to \$100,000 to Bethesda (and other possible charities) to avoid the disbursements being recorded as taxable income on your federal tax return. Check your own state tax code to see if it is also treated as non-taxable income. Act

now if you have not already taken your disbursement. Simply contact your IRA account manager and have them direct your disbursement to Bethesda Home. If you have already received your disbursement you can still contribute to Bethesda and claim a charitable deduction, if you itemize. Contact your tax accountant for more details.

Activities Director Report

Christmas at Bethesda means traditions, such as Christmas trees, a gift exchange, neighborhood parties, decorations, Christmas music, hearing the Christmas story and good baked treats. In addition, the Activities Department is trying something new. We will offer two bus trips—one for in-house residents and one for duplex residents—to McPherson to ride their trolley. The trolley, operated by the McPherson

Convention and Visitors Bureau, will take 22 passengers (per tour) for a neighborhood lights tour, complete with Christmas music, throughout the city of McPherson. Many people consider looking at Christmas lights part of their Christmas tradition, so this will provide a fun way to enjoy the sights. We’ll see---this may become part of the tradition at Bethesda, as well!

Resident Care / Facility Gift Ideas

- Linens - any amount appreciated - \$450 needed (sheets, bedspreads, pillow cases, etc.)
- Bath and hand towels - \$100/case of 48 (need 4 cases)

Dietary

- Wood grain serving trays - \$220
- Cloth napkins - \$60

Maintenance / Operations

- Resident room renovation - \$5,000 ea.
- Digital camera - \$130
- Stihl chain saw – 16” or 18” - \$325
- Window cleaning unit - \$300
- Commercial laundry dryer - \$5,000
- Used skid steer with bucket & forks

Keith's Foods in Goessel, Kansas contributes to Bethesda when you buy groceries with gift cards. "I would rather give 4% to Bethesda than to the credit card companies. I end up paying credit card companies \$600/mo. in credit card fees. I would much rather give that to support the ministry at Bethesda,"

said Keith Banman. Keith's Foods \$50 gift cards can be purchased via cash or check at the store, Crossroads Credit Union, Citizens State Bank and Bethesda Home. **Christmas Bonus:** During the month of December Keith will give you a \$5 gift card free of charge with the purchase of a \$50 Bethesda gift card.

It is also time for the annual renewal for Dillons, Bakers and Gerbes shoppers to re-enroll in the program on January 1, 2017, or ASAP thereafter, for purchases to be credited to Bethesda Home and for Dillons to contribute to the Bethesda Benevolent Care Fund. As of midnight 12/31/16 everyone currently enrolled will be deleted. DO NOT re-enroll before January 1. You will need to log on to dillons.com/communityrewards and sign in with your user name and password that you created for this account and enter 10035 (or select Bethesda Home) as your organization of choice to receive the Dillons donation. If you have not already

enrolled in this program, log on to the same Dillons web site and "Create an account," then follow the steps. Please contact either Pete Flaming or Terri Walker if you need assistance in re-enrolling or creating an account for this easy way for Bethesda to receive contributions from Dillons at no cost to you – but by just swiping your "Plus Shoppers Card." If you live in NE or MO and have either a Bakers or Gerbes store site, log on to their respective Community Rewards Program. 91 participants have generated \$3,369 of contributions from Kroger to Bethesda thus far in 2016. The more that participate, the more Bethesda receives.
